Treatment of income and resources of persons excluded from the CalFresh household

Some people cannot get CalFresh benefits at all. It may be because they are being punished for violating CalFresh program rules or are disqualified for a period of time. It may also be simply because the law says they are persons who cannot get CalFresh benefits. When a person is ineligible for CalFresh benefits, the CalFresh office must follow special rules to decide how much of the ineligible person's income, resources and deductions the CalFresh office will count when determining whether the other members of the household are eligible, and how much in CalFresh benefits the other members will get.

Here's how it all breaks down:
